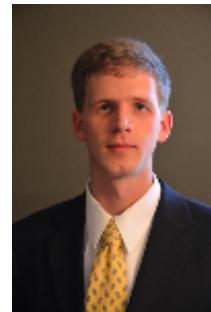


Alumni Newsletter

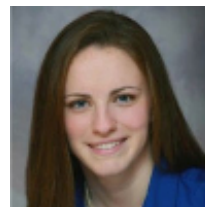

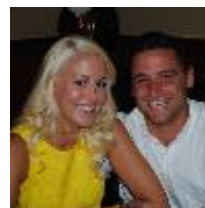
